Individuals benefit from a 24/7 emergency call service as well as training in how to safely and effectively use medical equipment at home. With home medical equipment individuals can monitor their own health in the comfort of their home.

Avera at Home provides hospice care in the patient's home with quality, compassionate care for people facing a life-limiting illness or injury. Hospice care involves pain management, and emotional and spiritual support with a team approach and medical care team. Bereavement support is provided to the patient's loved ones as well. Avera at Home also provides residential and inpatient care hospice in a 16 bed facility in Sioux Falls, South Dakota.

Avera at Home provides quality care in a patient's home. Home health care helps seniors, adults and pediatric patients who are recovering after a facility stay, or who need additional help to remain safe at home and to avoid unnecessary hospitalizations.
